### RAPORT

#### privind examinarea candidaturilor propuse din partea partenerilor de dezvoltare în cadrul Comisiei independente de evaluare a integrității candidaților la funcția de membru în organele de autoadministrare ale judecătorilor și procurorilor

Comisia juridică, numiri și imunități a examinat candidaturile propuse din partea partenerilor de dezvoltare și expune următoarele.

La data de 16 martie 2022 a intrat în vigoare Legea privind unele măsuri aferente selectării candidaților la funcția de membru în organele de autoadministrare ale judecătorilor și procurorilor cu nr. 26/2022.

În conformitate cu art.5 din Legea 26/2022, Comisia independentă de evaluare a integrității candidaților la funcția de membru în organele de autoadministrare ale judecătorilor și procurorilor este formată din 6 membri desemnați după cum urmează:

a) 3 membri cetățeni ai Republicii Moldova – la propunerea fracțiunilor parlamentare, cu respectarea reprezentării proporționale a majorității și a opoziției, aprobați cu votul a 3/5 din deputații aleși;

b) 3 membri – la propunerea partenerilor de dezvoltare, aprobați cu votul a 3/5 din deputații aleși.

În scopul desemnării membrilor prevăzuți la alin.(1) lit. b), partenerii de dezvoltare prezintă Parlamentului, printr-o scrisoare semnată în comun, o listă din cel mult 6 persoane eligibile. În cadrul Comisiei parlamentare juridice, numiri și imunități se examinează candidaturile propuse și se aleg 3 persoane care au obținut cel mai mare număr de voturi în cadrul ședinței comisiei parlamentare și care urmează a fi propuse plenului Parlamentului în vederea desemnării în calitate de membri ai Comisiei de evaluare. Pentru aceasta, comisia parlamentară elaborează proiectul unei hotărâri de Parlament, însoțit de un raport, care urmează a fi dezbătute în plenul Parlamentului și adoptate cu votul majorității prevăzute la alin.(1) lit. b).

Astfel, la Comisia juridică, numiri și imunități au parvenit propunerile din partea partenerilor de dezvoltare, după cum urmează: Carlos Castresana Fernandedez, Victoria Henley, Tilman Hoppe, Nona Tsotsoria, Herman Von Hebel, Ales Zalar.

Întru respectarea prevederilor art.5 alin (8) care stabilește că Membrul Comisiei de evaluare trebuie să corespundă următoarelor cerințe: are studii superioare; are o

reputație ireproșabilă; are cel puțin 10 ani de experiență în unul sau mai multe dintre următoarele domenii: juridic, economic, fiscal, al investigării infracțiunilor de corupție și celor conexe corupției, al verificării integrității; nu a deținut funcția de deputat în Parlament sau de membru al Guvernului în ultimii 3 ani; nu a făcut parte dintr-un partid politic în ultimii 3 ani; nu a deținut funcția de judecător sau procuror în Republica Moldova în ultimii 3 ani; nu a fost membru al organelor prevăzute la art.2 alin.(1) în ultimii 3 ani; cunoaște la un nivel suficient limba engleză, actele necesare stabilirii criteriilor date au fost prezentate comisiei și examinate de membrii acesteia.

Examinând candidaturile prin prisma rigorilor legale înaintate față de membrii Comisia independentă de evaluare a integrității candidaților la funcția de membru în organele de autoadministrare ale judecătorilor și procurorilor, membrii Comisiei cu votul unanim al membrilor prezenți (7 voturi pentru) propun următoarele candidaturi: Victoria Henley, Nona Tsotsoria, Herman Von Hebel .

Urmare a dezbaterilor, membrii Comisiei juridice, numiri și imunității, propun plenului Parlamentului candidaturile sus menționate, pentru a fi desemnate în funcția de membru al Comisia independentă de evaluare a integrității candidaților la funcția de membru în organele de autoadministrare ale judecătorilor și procurorilor. Proiectul de hotărâre se anexează.
