In Article 2, paragraph 2.5 the phrase „Ministry of Economy and Trade of Moldova” is replaced by the phrase „Ministry of Finance of the Republic of Moldova”, and the phrase „Ministry of Foreign Affairs of Hungary” is replaced by the phrase „Ministry of Foreign Affairs and Trade of Hungary”;

In Article 5, paragraph 5.1, the phrase „Ministry of Foreign Affairs of the Republic of Hungary” is replaced by the phrase „Ministry of Foreign Affairs and Trade of Hungary”.

The Ministry of Foreign Affairs and European Integration of the Republic of Moldova would be grateful if the Embassy of Hungary to the Republic of Moldova could confirm its agreement with this amendment by return of Verbal Note of the same content. The present Verbal Note, together with the Embassy’s Verbal Note of reply will constitute the amendment Protocol to the Memorandum of Understanding between the Government of the Republic of Moldova and the Government of the Republic of Hungary on development and cooperation, signed in Chisinau on December 22, 2006. The Protocol enters into force on the date of receipt by the Government of Hungary of the written notification from the Government of the Republic of Moldova of the completion of necessary domestic procedures for the entry into force of such agreement.
