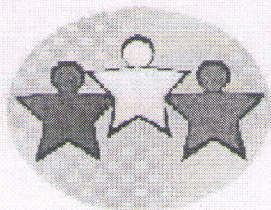



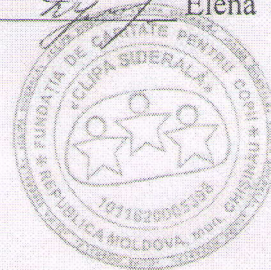
### Scrisoare de recomandare

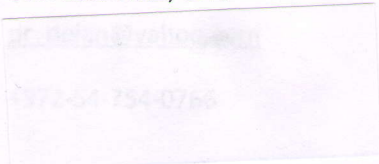
